

# TRUMANS BLUE RIDGE HEIGHTS

This is a subdivision of all that part of the Southeast Quarter (S.E. 1/4) of Section 11, Township 47, Range 33, and all that part of the Northeast Quarter (N.E. 1/4) of Section 14, Township 47, Range 33, all in the City of Grandview, Jackson County, Missouri, described as follows: beginning at a point on the East Line of Grandview Road that is 200.0 feet North of the intersection of the Westerly Line of Blue Ridge Boulevard Extension with the East Line of Grandview Road; thence East, 237.16 feet to a point on the Westerly Line of Blue Ridge Boulevard Extension; thence Northeast along the Westerly Line of Blue Ridge Boulevard Extension, a distance of 1051.55 feet, to a point on the North Line of said Section 14; thence continuing Northeast along said Westerly Line of Blue Ridge Boulevard Extension, a distance of 353.24 feet; thence N. 44° 44' 30" W, a distance of 299.75 feet to a point on the Easterly Right-of-Way Line of the Kansas City Southern Railroad; thence S. 45° 15' 30" W, along said Easterly Right-of-Way Line, a distance of 494.31 feet to a point on the North and South Centerline of said section 11, also being the centerline of Grandview Road; thence S. 0° 02' 30" W, a distance of 164.45 feet, along the North and South Centerline of said Section 11, to the Southwest corner of the S.E. 1/4 of said Section 11; thence South, along the North and South Centerline of said Section 14, a distance of 1034.31 feet; thence East, a distance of 30 feet, to the point of beginning. All except that part thereof used as and designated as CEMETERY.

The undersigned proprietors of the above described tract of land have caused the same to be subdivided in the manner shown on the accompanying plat, which subdivision and plat shall hereafter be known as 'TRUMANS BLUE RIDGE HEIGHTS'.

The Road and Boulevard shown on this plat and not heretofore dedicated to public use as thoroughfares, are hereby so dedicated.

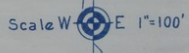
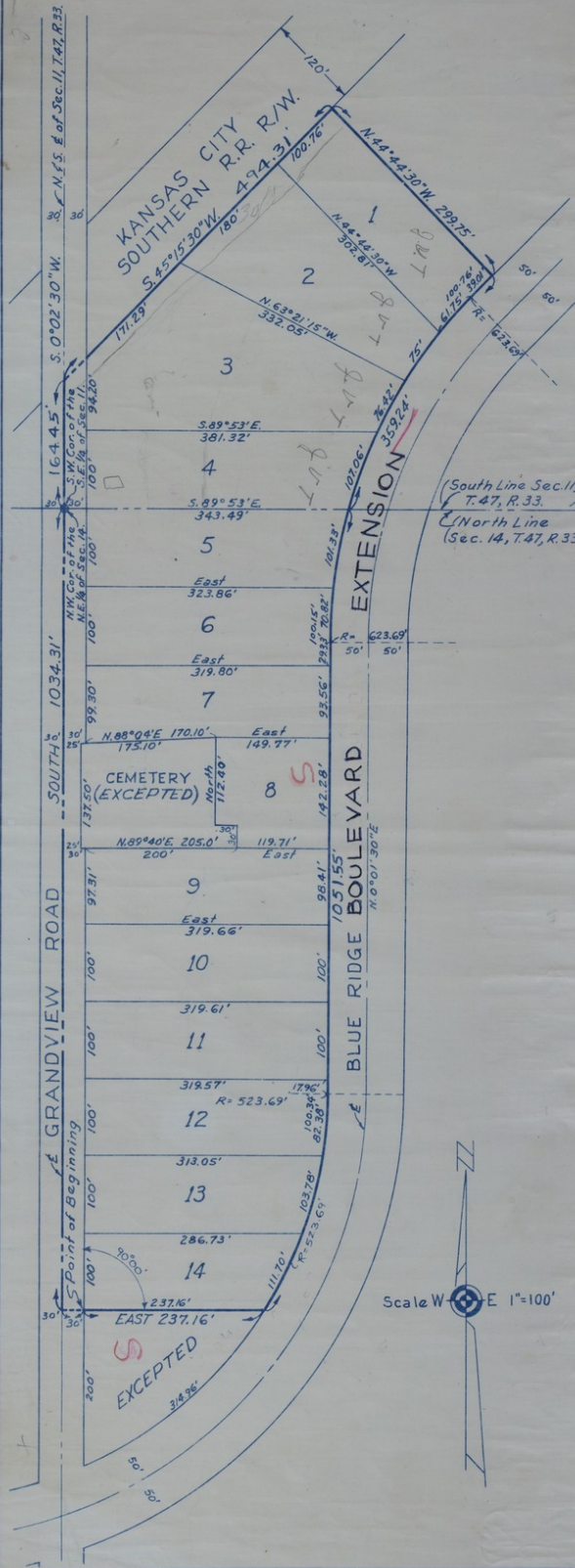
