



# Truman Heights

This is a subdivision of all that part of the Southeast Quarter(¼) of Section 11 Township 47 Range 33 in Jackson County, Missouri, except the South 15 Acres of said Southeast Quarter(¼), lying West of the West line of a public road known as U.S. Highway No 71 and Northwesterly of the Northwest line of a public road known as Blue Ridge Boulevard Extension and Southeasterly of the Southeasterly line of the right of way of the Kansas City Southern Railway Company as said highway and right of way lines are now established.

The undersigned proprietors of the above described tract of land have caused the same to be subdivided in the manner shown on the accompanying plat which subdivision and plat shall hereafter be known as TRUMAN HEIGHTS.

The roads and highways shown on this plat and not heretofore dedicated to public use as thoroughfares, are hereby so dedicated.

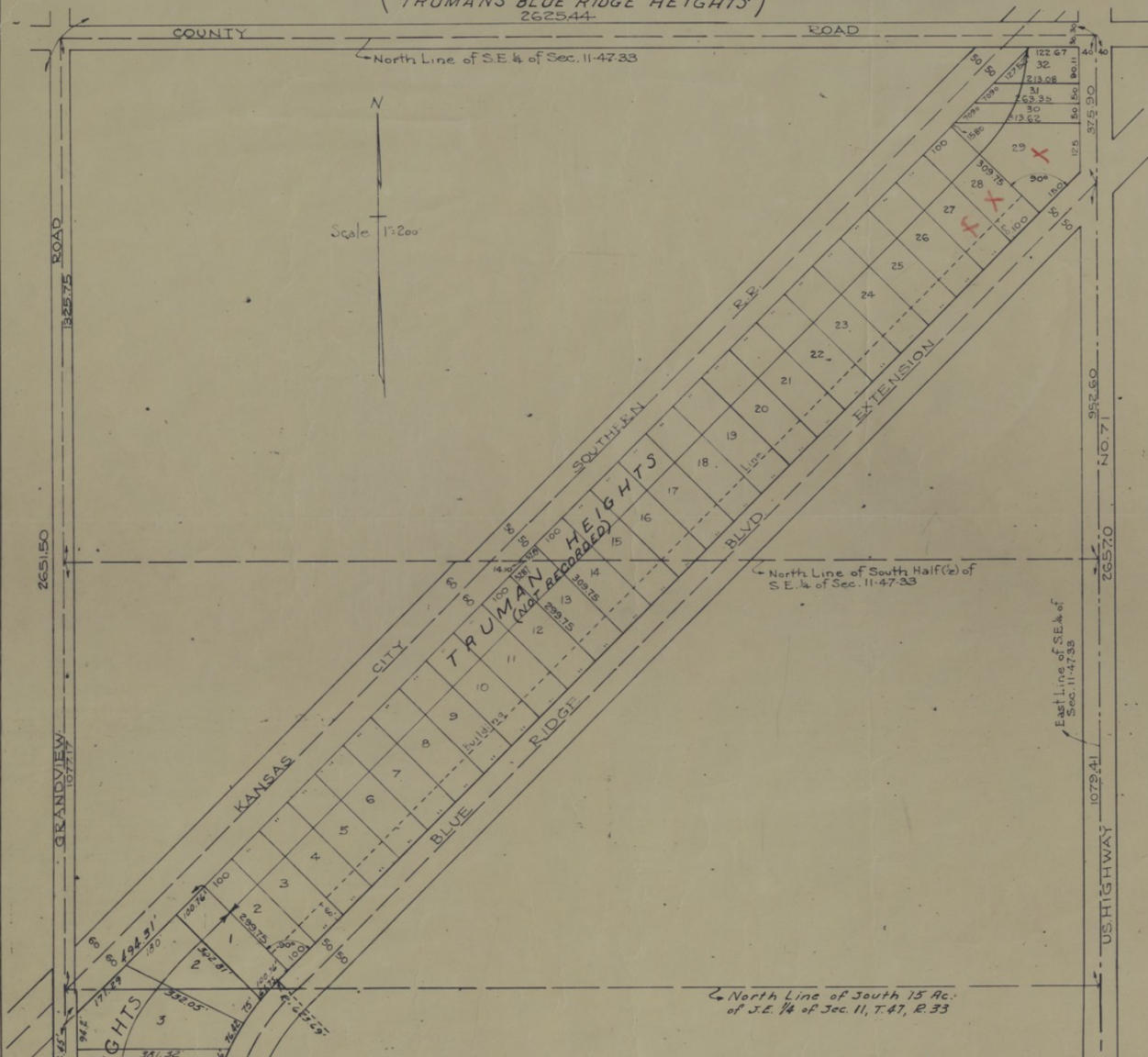
